# Sloughhouse Resource Conservation District Cosumnes Subbasin DRAFT Proposed Fee Approach

## Year 1 (Pre-GSP) – PRIMARY GOAL:

5 GSAs will implement an Administrative Fee based on usage/extraction. The 5 GSAs are:

- Sloughhouse Resource Conservation District
- County of Sacramento
- Southeast Sacramento County Agriculture Water Authority (SSCAWA)\*
  - o Omochumne-Hartnell Water District
  - Clay Water District
  - Galt Irrigation District

#### Administrative Fee Structure:

- Each GSA (or JPA if formed in time) applies an extraction fee (~\$10/irrigated acres OR ~\$3/AF) to cover <u>Administrative Costs</u>. This will contribute ~\$450,000 towards collaborative administrative efforts. Additional funds (on top of the fee collect to cover shared administrative activities) could be generated to support individual GSA expenses.
- The City of Galt GSA (~\$100,000) and the Amador County Groundwater Management Authority (~\$45,000) will contribute ~\$145,000 towards collaborative administrative efforts.
- This fee would not have a sunset date but the intention is to have it replaced by the post-GSP fee approach presented below ("Year 2 and Beyond").
- In year 1, there will be ~\$595,000 for Administrative Costs.

#### **Timeline for Year 1:**

- Technical Data Gathered / Fee Report Developed Now to May
  - Need to identify parcels that are irrigated by groundwater (assume if not using surface water, they are using groundwater) and estimated use.
- Additional Outreach May/June 2021
  - Not required but should be prioritized.
- Ordinance/Resolution (still needs clarity)

- Final Ordinance/Resolution Hearing and Adoption July 14, 2021
- Fee Report Provided to County July 31, 2021
- Fee included on property taxes November 2021

## **Potential Example for Year 2 and Beyond:**

Either the 5 individual GSAs or a Joint Powers Authority consisting of those GSA will implement an Administrative Fee based on usage/extraction in the jurisdictional area of those GSAs. Those GSAs are:

- Sloughhouse Resource Conservation District
- County of Sacramento
- SouthEast Sacramento County Agriculture Water Authority
  - Omochumne-Hartnell Water District
  - Clay Water District
  - Galt Irrigation District

This two-part fee that would cover <u>Administrative Costs</u> and <u>Projects Costs</u>. This will be subject to a Proposition 218 process.

#### Administrative Fee Structure:

- An extraction fee, using parcel size as a proxy for usage, applied to property tax roll
- A tiered rate will be used (<2 acre and no gw, <2 acres with gw, 2-10 acres, 10-20 acres, 20+ acres)
- Generates ~\$265,000 annually
- City of Galt GSA and Amador County Groundwater Management Authority GSA will contribute ~\$147,000 annually.
- This will generate **~\$410,000 for Administrative Costs** annually.

### **Projects Fee Structure:**

- An extraction fee, using irrigated acres as a proxy (~\$10/irrigated acre OR ~\$3/AF), will be applied to all water users in the Subbasin except those who use < 2 AFY (de minimis). This will generate approximately ~\$450,000 for Project Costs annually.
  - \$450,000 will not cover all of the project costs in the long run as budgeted. However, the \$10/irrigated acre amount is an agreeable starting point established through discussions with several stakeholders. Once there is more progress toward Project and Management Action Implementation there may be positive support for increasing the fee to help fund the Plan. As currently projected, this fee would need to be increased or the Cosumnes Subbasin long term Project and Management Actions plan/funding structure would need to be revised. It is the intention of GSAs to review the fee at the same intervals as the GSP 5-year updates.
- The City of Galt GSA will contribute ~\$X,XXX towards projects and management actions based on ~XXXX AF of groundwater use.
